

## Department of Economics:

### ◆Change of Major Requirements

- Completion of Math 2A, Math 2B, Econ 20A and Econ 20B with an average GPA of at least 2.5 in these four courses. In addition, they must all have a grade of "C" or better.
- Cumulative GPA of at least 2.0.
- Previous academic quarter GPA of at least 2.0 (excludes Summer Session)

### ◆Double Majors with Mathematics (School of Physical Sciences)

For those students who pursue a double major with Business Econ or Econ AND Math, please note the following:

- Math 2D AND Math 3A will count for Math 4
- Math majors with a concentration in Mathematical Finance may only overlap the following: Econ 20A-B, Econ 105A-B-C/Econ 100A-B-C (contact Physical Sciences to see if Econ 100-series is allowed for use in your Math major) and Econ 122A only.
- MAY NOT OVERLAP: Math 176/Econ 135, Econ 132A, and Econ 134A (courses may not be used for the Business Economics or Economics major at all).
- Students pursuing these double majors should check-in with academic counselors in Physical Sciences, as well as Social Sciences for progress checks and no rely on DegreeWorks.

### ◆Honors Program in Economics

Admission Requirements:

- 3.4 GPA or better in upper-division Economics courses and an overall GPA of 3.2 or better
- Completion of ECON 100A-B-C.
- Must be completed OR at least enrolled in for Fall: ECON 122A or ECON 123A

### Requirements for the Honors Economics:

Students in the Honors Program must complete an honors thesis during the two-quarter Honors Colloquium:

\_\_\_\_\_ Econ H190A design the project, conduct the preliminary research, and begin to write the paper

\_\_\_\_\_ Econ 190BW complete the research project, write the honors thesis, and present the results

Completion of the program will satisfy the upper-division writing requirement.

#### **A. THREE International Studies Lower-Division Core Courses:**

#### **B. THREE Upper Division International Economics elective courses chosen from:**

Economics 157, 161B, 162, 164A, 165, 167 \_\_\_\_\_

#### **C. THREE International electives (only ONE may be lower-division) chosen from:**

Int'l Studies 111C, 112A, 122, 179 (when focus is on international economy); Political Science 141B, 141C; History 21A, B, C \_\_\_\_\_

NOTE: \*NO MORE THAN 2 courses may overlap between the major and the specialization requirements.

\*Students pursuing this specialization MAY NOT double major or minor in International Studies.
